

I don't know if others gave you a heads up. I am getting close to finishing and will need my plastic set back. Please let me know if your done using my playfield as well. I'd like to start swapping it into the other game. I saw in some pics threads the clearcoat on some of the playfields are rippling at the point where posts were screwed down to tight. I took great care in not over tightening anything that screwed into the playfield. I'm wondering if you happen to know when the playfield you sent me was cleaned. When I'm finished repopulating the playfield I'll leave the game in it's cabinet and not play her for the required months so it fully cures. Was hoping you could suggest a timeframe for fully cured. You're last email started with: sorry but it is not my only thing of the day to work on the parts for a repro game. I have other more important projects right now. While patiently waiting for a month to hear from you and going on almost a year now to get my playfield and plastics back all I've been hearing is how Stern is redoing Quiksilver for a set Q2z retheme. So for this whole year while explaining to you that I needed my Playfield and plastics back asap so I could rebuild the game to sell it, you knew the whole time you weren't giving them up?? I watched 3 diff games set and lost out on Adam's sale while my Quiksilver's value will decline because you're using my playfield as a reference for your "more important project"?!! When the Searchlight repro was done the value of Searchlight went down and you knew I was trying to put the game back together to sell it!

I offered to accept another Q2 repro so you could keep the original for reference to have us both be satisfied only to be ignored. I begged for at least my plastics back so I can sell the machine and you couldn't be bothered. You could have easily had Stern reach out to me to explain and I wouldn't have said a thing.
